Bids for the construction of the Project will be received at the **Wythe County Board of Supervisors Chambers** located at **340 South 6<sup>th</sup> Street, Wytheville, VA 24382**, until **1 August 2024** at **2:00** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

**Construction of a pump station, 3500 lf of gravity sewer, 5300 lf of 6" force main and related appurtenances just south of Fort Chiswell, Virginia.**

Separate Bids will be received for the following Contracts:

Owner will announce the total construction budget after receipt of all bids and prior to opening bids. The Project has an expected duration of **210** days.
